

PARENT RESPONSIBILITIES & AGREEMENTS

Please read each agreement below and initial your acknowledgement.

*For the purposes of this form, the student's parent/guardian will be referred to as "I" or "me".
Newport Coast Child Development Preschool, its Staff and affiliates will be referred to as "NCCDP"..*

_____ I have received and read a copy of the NCCDP Parent Handbook, and agree to abide by the policies therein.

_____ NCCDP does not allow any foods that contain peanuts or tree nuts, or foods which have been processed in a facility that also processes peanuts and/or tree nuts to be served to the class (for snack or at class parties). I am aware of and agree to abide by the Nut-Free Policy to ensure the safety of all NCCDP students.

_____ NCCDP strives to maintain a peanut and tree nut free campus, and staff will check labels and be conscientious in ensuring food safety for all students. However, food that is brought on campus by other students or parents (i.e. lunches that contain food that is out of original packaging, or on the playground after school) may potentially contain or have been processed in a facility that also manufactures peanuts and/or tree nuts. NCCDP does not guarantee that students will not be exposed to peanuts and/or tree nuts.

_____ I understand that my child will be photographed by NCCDP or other parents in my child's class to document class parties and classroom activities. If I prefer not to have my child photographed, I understand that it is my responsibility to inform my child's teacher(s) and Room Parent(s).

_____ I understand that my child may be photographed for the NCCDP website, advertising and any publications which NCCDP staff authorizes. If I prefer not to have my child photographed, I understand that it is my responsibility to inform NCCDP.

_____ I understand that all students are photographed annually by an outside vendor for the school yearbook. If I do not wish to have my child photographed, it is my responsibility to inform NCCDP and my child's teachers.

_____ I understand that school policy prohibits posting any photos of NCCDP students online. I agree not to post any pictures of children (other than my own) online, on social media sites or other shared media.

_____ I agree to promptly notify NCCDP of any changes in our address, phone numbers, place of employment, or change in family status.

_____ I understand that, weather permitting, my child may participate in water play or other messy preschool activities. Casual dress that can get dirty is the best attire for my child at preschool.

_____ I agree that NCCDP may apply sunscreen to my child as needed. If my child requires special sunscreen, I must provide it to my child's teachers.

_____ Any provision of babysitting or tutoring services by NCCDP staff members shall be after preschool operating hours and off preschool premises. Any such services for children enrolled in the preschool are not sponsored by the preschool; these services are not included in NCCDP's liability insurance coverage. The arrangement, provision, and payment of these services are an arrangement entered into exclusively by me and the adult who will be providing babysitting services. The actions of any preschool employee outside the preschool premises and hours of operation are not the responsibility of NCCDP.
